Your IAMAW Negotiations Committee (George Kuehnl, Martin St-Maurice, Nadine Legault, Nathalie Beauchamp and Peter Greenberg), and the Company representatives (Dominique Jalbert, Suzanne Lapointe, Amélie Jobin and Sylvain Aubin) met in Mediation on September 18, 2017 in front of Helene Madore, mediator.

Your IAMAW Bargaining Committee is pleased to announce that a tentative agreement has been reached! This tentative agreement is supported by your Bargaining Committee and is subject to a ratification vote by our membership.

As the tentative agreement represents a body of work that began with our first direct bargaining session on November 8, 2016, the Bargaining Committee needs to verify all documents with the Company that have been exchanged throughout the bargaining process. Following this, the Bargaining Committee will need to prepare the highlights of the tentative agreement for presentation to our membership.

Your Union is also in the process of reviewing dates for base meetings for presentation of the Tentative Agreement. Once dates and locations of these meetings are confirmed, they will be communicated to our membership.

The dates of the ratification vote on the tentative agreement will be determined and communicated after all base meetings have been completed.

In addition, the Union will provide further updates as information becomes available.
